BOAT REGISTRATION

Any resident operating a boat on Lake Montclair is required to register with MPOA. Residents who do not register their boats by November 10, 2023 will incur a \$15 late fee. Additionally, any boat stored at West Beach boat racks is subject to a \$25 annual storage fee. Boat stickers are to be attached to the port (left) side bow (front).

DOCK PERMIT REGISTRATION

Annual Dock and Shoreline Improvement Permits are required for all docks on Lake Montclair and any shoreline improvements between the property boundary lines of lot eligible for a dock and Lake's water surface (including, but not limited to: stairways, steps, walkways, landings, fences, boat racks, irrigation systems, etc.), regardless of whether or not a dock exists. All applicable improvements must be listed on the renewal permit when submitted to MPOA.

Please have a copy of the current General Liability Insurance of no less than 1,000,000. In addition, the MPOA must be listed as the certificate holder or as additional insured at the time of registration.

President's Message

Greeting Montclairions!

On August 23rd, the Montclair BODs met to approve Resolution 23 - 002 initiating civil litigation against C.J. Eagle LLC. The BOD has been unsuccessful in negotiating to recover C.J. Eagle's share of the dam maintenance costs, under the 1994 Lake Montclair Dam Maintenance Agreement. An agreement under which dam maintenance costs are proportionately shared between the Montclair Country Club owner and the Association. For the benefit and protection of the Association, the BOD has determined it is in the Association's best interest to file a civil action against C.J. Eagle in Prince William County Circuit Court. I will remind residents, the BOD actively pursues all collections from homeowners, contractors, or businesses to which the Association may be entitled; this is not different.

On September 13th, Prince William County (PWC) Environmental Services provided a detailed brief on the PWC Resource Protection Area Ad-Hoc Working Group's current efforts to help Montclair protect our sensitive lake's ecosystem, water quality, residential lots, and environment. This was followed by the Virginia Cooperative Extension's discussion on restoration projects and management, and Prince William Soil and Water Conservation's discussion on available grant opportunities for Montclair residents. I want to thank all the presenters: Clay Morris, Valerie Huelsman, Alex Murphy, and Josie Anderson for their efforts. These presentations have provided me with a significant degree of education and appreciation for our environment, and the BOD with possible resources for Montclair RPA and common area projects.

Lastly, the Budget and Finance Committee is finalizing the development of the 2024 Fiscal Year budget. The annual budget is critical in understanding how our annual assessments are allocated against the operation, maintenance, and sustainment of the community. I encourage all residents to attend, review, and comment during this cycle. Let's all get involved; let's all get informed!

COMMUNITY WATCH INCIDENT REPORT – AUGUST 2023

- Program Manager Clay Morris with Prince William County Environmental Management Division gave a presentation about RPA best practices, and the goals of a joint ad-hoc working group formed by the county with MPOA representation to restore a buffer around Lake Montclair. Valerie Huelsman with Virginia Cooperative Extension (VCE) gave a presentation about the ad-hoc group's proposal to restore a buffer near the Dolphin Beach pavilion as an example to begin restoring a buffer within the common areas, with the aid of grant funding offered by the Virginia Conservation Assistance Program (VCAP). Conservation Specialist Alex Murphy with PWC provided an additional presentation regarding VCAP and funding opportunities. These presentations will be made available on the MPOA website as soon as possible.
- Approved the voting procedure for the 2024 Annual Meeting Precinct Election.
- Approved the 2024 Annual Meeting schedule, date, time, and location.

BOARD BRIEFS

- Approved the Lion's Club to display the "Drug-Take-Back" banner at the corner of Country Club and Waterway entrance the week of October 23rd to October 28th.
- Swimfest contract with the Potomac Marlins to host open water swim fest events for up to three years was approved, the first event will be May 19, 2024. The organization will pay MPOA \$2,500.00 for the business use of Dolphin Beach for the first year, with an additional \$500.00 increase each subsequent year.
- Approved a proposal from Brightview to clear invasive plant growth around a stormwater culvert at the corner of Sheffield Drive and Camelot Court. Also approved the cutting down weeds in excess of 12 inches to come into compliance with PWC vegetation ordinance, and to refer these parcels to the LFMC for a recommendation for continuous maintenance and remediation by the November BOD Meeting.
- A new trash rack was approved for a storm water easement at 16185 Sheffield Drive for an expenditure not to exceed \$15,000.00.
- A new, robust Events Schedule for fiscal year 2025 was approved by acclamation. The new schedule more than doubles the number of activities next year, while reducing the overall activities' budget and significantly increasing projected income.
- Changes to the Board liaison roster were approved to appoint Chris Dvorak to the Safety Committee and Brian Proctor to the Signage Ad-hoc Committee.
- The Yard Sale Event motion was reconsidered from last month's meeting to add Dolphin Beach as an optional location for the event, in addition to Southlake Rec Center.


ANNUAL LAKE LOWERING



Beginning November 6, 2023, the lake will be lowered gradually by a total of three feet, over the course of a few days. This process is to allow for winter cleaning of the dam and docks along with the end of season inspections as necessary. This lowering also provides an opportunity for lakefront owners to inspect, repair, and perform maintenance to their docks. The level will remain lowered for 14 days and then allowed to raise naturally.

Please remember to submit a PIR for dock repairs, if required. Please review Community Guidelines Article 5.4.8 Docks, Piers, Wharves, and Shoreline Improvements.

In addition, if you are a lakefront owner, please make sure that you take the necessary precautions to secure your personal property.



Montclair is comprised of thousands of families of varying sizes and lifestyles and should be represented by a Board of Directors with just as much diversity. This year's Annual Meeting & Election is the perfect opportunity for candidates to step up and represent not only their precinct, but their fellow Monclairions as well. We encourage you to learn more about what the Board of Directors does and consider becoming a candidate for a Precinct Representative position in the upcoming 2024 Annual Election of the Board of Directors.

Precinct Representatives serve as members of the board and act as a resource for their respective precinct. Precinct reps may be contacted by members of the precinct to voice concerns regarding their home or business they feel the board should discuss. Find out what precinct you live in at www.montclairva.com/precinct-street-listing.

Serving on the board is much more than simply fulfilling a community service. It is taking on a role as a fiduciary, which means to serve all the members of the community to the highest standard of care and loyalty under the law. The board is responsible for making and enforcing policies of the association and relies upon its officers and agents to execute those decisions. After the community elects the directors, the board will hold its own election determining the officers of the corporation for the upcoming year. The officers consist of a President, 1st Vice President, 2nd Vice President, Secretary, and Treasurer. The board may also consider appointments to various committees and assign directors as board liaisons to those committees. The duties and responsibilities of each of these officer positions are detailed in article five of the MPOA Bylaws and article two of the Community Guidelines.





Candidates for the board must be an association member in good standing. Any special skills or experiences that could benefit the community are welcome. For example, experience with putting together budgets, managing or negotiating vendor contracts, or having a background in communications are all desirable.

While all skills and experiences make a well-rounded and effective team, the candidate only needs to have the desire to improve Montclair with an interest in how the association is governed.

The board holds regularly scheduled meetings on the second Wednesday of each month to address association business. There may also be a need for additional special meetings to discuss critical, time-sensitive items on occasion.

Each board member serves on a quarterly rotation of various subcommittees, and these committees meet as needed. Committees of the board are further detailed in Section 3.3.4 of the Community Guidelines.

What time commitments will I be making

l'm interested, what do I do now It is important to know and understand that by accepting a board position, you are accepting a real, legally binding responsibility for which there may be consequences for actions taken by the board either as a group or individually. There is no doubt it is a challenging role but knowing the impact you are making on our community is worth it!

Applicants will need to submit the completed Call for Candidates form with a candidate photo and election statement (see Call for Candidates form for more details).
